Some people with heart failure can experience pain or discomfort towards the end of their life. They should be assessed using a pain scale. Pain-relieving medicines can be used to relieve pain and discomfort; this can include opioid (eq morphine) and non-opioid medicines (paracetamol).

Caring for someone with heart failure at the end of life

Tricyclic antidepressants are best avoided in heart failure. Pain is very common, especially in the terminal stages: One common cause is stretching of the capsule of the liver. It should be managed in the usual way for palliative care except that non-steroidal anti-inflammatory drugs

should be avoided.
