For companies wholly or mainly in England, a new regime is being implemented by Ofwat for the adoption of sewers and lateral drains from mid-2019. The new regime is set out in the November 2017 Code for Adoption Agreements.

Property owners are no longer responsible for certain sewer pipes that connect their homes to public sewers. On 1 October 2011, legislation introduced by the government transferred responsibility for private sewers and lateral drains to Southern Water – providing clear ownership and better long-term maintenance for the sewer network.

Sewers for Adoption contains guidance for the design and construction of sewers that will be adopted by Sewerage Undertakers. In the area of water and sewerage companies wholly Sewers for Adoption was superseded by the Ofwat Adoption Code <https://www.ofwat.gov.uk/regulated-companies/markets/connections-market/code-adoption-agreements/> and specifically the Sewerage Sector Guidance from 1st April 2020.

Water companies have also published principles to deal with the transition between the current Sewers for Adoption regime and the new SSG. These are set out below, along with the other SSG documents. In general, applications using current standards will continue to be accepted for six months from the implementation of the SSG on 1 April 2020.
